A forum or debate for candidates for the office of Council member of the Town of Addison, Texas is to be held on April 21, 2014 at 7:00 P.M. at the Addison Conference Centre. This forum or debate is not sponsored, sanctioned, or hosted by the Town. Members of the Addison City Council may attend the forum or debate, with the possibility that a quorum of the City Council may be present.

The forum or debate may or will include an overview and discussion of the Town, its projects and its future, and may or will include the following matters and topics: the Town's strategic plan; goals and objectives; budget; finances; tax rate; bond propositions and their implementation; Belt Line Road and Midway Road and reconstruction; new water tower and education center; Addison Airport, including strategic planning; Vitruvian development; DART and transportation; education; economic development and business growth and retention, including the Baylor University Accelerated Ventures program; zip codes; special events; new construction and building, including Village on the Parkway and adjacent properties; Visit Addison; Addison Conference and Theatre Centre; Addison Athletic Club; parks, recreation, trails, pedestrian connectivity, public infrastructure and facilities, including the new water tower, and capital projects; public art; sustainability; recycling; utilities, and utility rates; zoning and code enforcement; public safety and law enforcement; interlocal cooperation with neighboring cities; Town personnel and compensation; animal control; various non-profit entities, Town facilities and projects, and local, regional and Statewide organizations to which the

members of the Council may serve as liaison, including Addison Business Association, Metroplex Mayors Association, Metrocrest Chamber of Commerce, North Central Texas Council of Governments, Regional Transportation Council, North Texas Commission, Vision North Texas, Addison Legacy Foundation, Community Partners Bureau, Water Tower Theatre, Texas 21.

If a quorum of the City Council attends, no action will be taken by the Council.
