#### **AGENDA CAPTION:**

Discussion and consideration of a resolution establishing a vote of record that proposes a property tax rate for the Town's fiscal year beginning October 1, 2012 and ending September 30, 2013, and designating dates for the holding of a public hearing regarding, and a date for the adoption of, the property tax rate for the said 2012/2013 fiscal year.

### **FINANCIAL IMPACT:**

The costs associated with publishing notices of the tax rate are approximately \$6,000 and will be paid from the Financial & Strategic Services department.

#### **BACKGROUND:**

The State's Truth in Taxation law requires calculation and publication of each taxing entity's net effective tax and rollback tax rates. These rates have been calculated by the Dallas County Tax Appraiser to be \$0.561941 and \$0.629247 per \$100, respectively. These rates will be published in the August 3, 2012 edition of the Dallas Morning News. Included with this agenda item is a copy of the publication notice.

The city manager's proposed budget assumes a property tax rate of \$0.625, which exceeds the net effective tax rate. Should the council consider a rate higher than the net effective rate, the Truth in Taxation law requires a vote of record, publication of the result of the vote of record and two public hearings. Whatever tax rate council adopts for next year's budget, it can be no higher than the rate established by the vote of record, although it can be less than that rate.

### **RECOMMENDATION:**

Because the city manager's proposed budget provides for a tax rate exceeding the net effective rate, it is recommended that Council establish a rate through the attached resolution.
