The OWNER agrees to pay the CONTRACTOR \$<u>95,368.65</u> in current funds for the performance of the Contract in accordance with the Bid submitted thereof, subject to additions and deductions, as provided in the General Provisions, and to make payments of account thereof as provided therein.
