A RESOLUTION OF THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS APPROVING A CONTRACT AGREEMENT BETWEEN THE TOWN ADDISON CARRUTHERS OF AND LANDSCAPE MANAGEMENT, INC., FOR TURNKEY LANDSCAPE / IRRIGATION MAINTENANCE OF THE VITRUVIAN PARK, SURVEYOR WATER **TOWER & DEMONSTRATION GARDENS ALONG WITH MEDIANS ON** SPRING VALLEY ROAD, BELT LINE ROAD, MIDWAY ROAD, AND ARAPAHO ROAD AND INCLUDING DALLAS PARKWAY RIGHT-OF-WAY IN AN AMOUNT NOT TO EXCEED \$96,000.00 ANNUALLY, CITY AUTHORIZING THE MANAGER TO EXECUTE THE AGREEMENT, AND PROVIDING AN EFFECTIVE DATE.

BE IT RESOLVED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS:

<u>Section 1.</u> The Contract Agreement between the Town of Addison and Carruthers Landscape Management, Inc. for turnkey Landscape / Irrigation Maintenance of Vitruvian Park, Surveyor Water Tower & Demonstration Gardens along with medians on Spring Valley Road, Belt Line Road, Midway Road, Arapaho Road and Dallas Parkway Rights-of-Way in an amount not to exceed \$96,000.00 annually, a copy of which is attached to this Resolution as <u>Exhibit A</u> and which incorporates the Town of Addison's General and Specific Conditions for construction contracts, and the Advertisement for Bids, Instruction to Bidders, General Provisions, Special Provisions, Plans and other bid documents, is hereby approved. The City Manager is hereby authorized to execute the agreement.

Section 2. This Resolution shall take effect from and after its date of adoption.

The OWNER agrees to pay the CONTRACTOR \$ <u>96,000.00</u>, in current funds for the performance of the Contract in accordance with the Bid submitted thereof, subject to additions and deductions, as provided in the General Provisions, and to make payments of account thereof as provided therein.
