A RESOLUTION OF THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS APPROVING AN INTERLOCAL AGREEMENT WITH DALLAS COUNTY FOR A \$5,000.00 CONTRIBUTION TO THE REGIONAL CENSUS FUND TO ENGAGE, EDUCATE AND ACTIVATE RESIDENTS IN HISTORICALLY UNDERCOUNTED COMMUNITIES; AUTHORIZING THE MAYOR TO EXECUTE THE AGREEMENT; AND PROVIDING AN EFFECTIVE DATE.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS:

Section 1. The Interlocal Agreement with Dallas County for a \$5,000.00 contribution to the regional census fund to engage, educate and activate residents in historically undercounted communities, attached as **Exhibit A** and incorporated herein, is hereby approved and the Mayor is authorized to execute the agreement.

Section 2. This Resolution shall take effect from and after its date of adoption.

EXHIBIT A

INTERLOCAL AGREEMENT BETWEEN TOWN OF ADDISON AND DALLAS COUNTY, TEXAS

This agreement is made this ____ day of _____, 2019 between the Town of Addison and Dallas County, Texas.

Pursuant to the authority granted by the "Texas Interlocal Cooperation Act," Chapter 791 Texas Government Code providing for the cooperation between local governmental bodies, the parties hereto, in consideration of the premises and mutual promises contained herein, agree as follows:

WHEREAS, the contract is made under the authority of Chapter 791 of the Texas Government Code; and,

WHEREAS, the parties, in performing governmental functions or in paying for the performance of governmental functions hereunder shall make that performance or those payments from current revenues legally available to that party;

WHEREAS, the governing bodies of each party find that the subject of this contract is necessary for the benefit of the public and that each party has the legal authority to perform and to provide the governmental function or service which is the subject matter of this contract; furthermore, the governing bodies find that the performance of this contract is in the common interest of both parties; and that the division of cost fairly compensates the performing party for the services under this contract.

WHEREAS, this agreement is authorized by the Town of Addison by Resolution No. _____, dated _____, 2019.

I.

Dallas County and Town of Addison mutually desire to organize, educate and activate residents, in historically underrepresented communities that are at risk of being disproportionately undercounted, regarding the importance of participating in the 2020 Census. This partnership is intended to provide resources, connections, and relationships in order to increase engagement and participation among historically underrepresented and undercounted communities in Dallas County.

II.

Dallas County intends to utilize a regional census fund to empower organizations and coalitions that work specifically with historically undercounted communities to engage, educate and activate residents. The regional census fund shall be funded by Dallas County and municipalities within Dallas County, including Town of Addison.

III.

Town of Addison shall contribute Five Thousand and No/100 Dollars (\$5,000.00) to the regional census fund, which will be utilized by Dallas County. Dallas County commits that, at a minimum, at least the amount of funds provided to this endeavor by Town of Addison toward the regional census fund shall be spent within the borders of Town of Addison.

IV.

This agreement shall take effect upon execution by both signatories.

V.

This agreement shall be in effect from the date of execution until the 2020 Census is completed.
