SECTION 1. The recitals set forth above are true and correct and are incorporated as if fully set forth herein.

SECTION 2. The City Council does hereby adopt and approve the list of qualified brokers, dealers, and financial institutions for Fiscal Year 2020-2021, attached hereto as **Exhibit A** and incorporated herein.

SECTION 3. This Resolution shall take effect upon its passage and approval.
