

**RESOLUTION NO. R21-\_\_**

**A RESOLUTION OF THE CITY COUNCIL OF THE TOWN OF ADDISON, TEXAS  
APPOINTING MEMBERS TO SERVE ON THE COMMUNITY PARTNERS  
BUREAU FOR A TERM COMMENCING JANUARY 1, 2022 AND PROVIDING AN  
EFFECTIVE DATE.**

**WHEREAS**, pursuant to Chapter 2 of the Town of Addison Code of Ordinances, the Addison Community Partners Bureau (CPB) was established to work volunteers to serve as the Town’s representative or liaisons to the non-profit organizations that the City provides grant funding; and

**WHEREAS**, the current organizations included in the Community Partners Bureau with funding in FY 2022-2023 Budget include the following organizations:

- Dallas Cat Lady
- Metrocrest Services
- On Eagles Wings, Inc., dba Woven Health Clinic
- The Steven A Cohen Military Family Clinic at Metrocare Services
- The Family Place

**WHEREAS**, the CPB was initially created a policy for the CBP with Resolution No. R13-010. The policy was subsequently amended through Resolution Nos. R15-007, R17-48 and R21-005; and

**WHEREAS**, the City solicited applications from all residents of the City appointments to the City’s Boards and Commissions.
