AN ORDINANCE OF THE TOWN OF ADDISON, TEXAS, APPROVING A RELEASE AND QUITCLAIM OF DRAINAGE EASEMENT ABANDONING THE PUBLIC DRAINAGE EASEMENT GRANTED TO THE TOWN OF ADDISON IN THAT CERTAIN EASEMENT DEDICATION RECORDED IN VOLUME 80007, PAGE 149, DEED RECORDS, DALLAS COUNTY, TEXAS; AUTHORIZING THE CITY MANAGER TO EXECUTE AND RECORD THE SAME IN THE OFFICIAL PUBLIC RECORDS OF DALLAS COUNTY, TEXAS; AND PROVIDING AN EFFECTIVE DATE.

SECTION 1. The Town of Addison, Texas ("Town") hereby approves the Release and Quitclaim of the Drainage Easement attached hereto incorporated herein as **Exhibit "A"** (the "Release"), it being the intent of the Town to abandon and quitclaim all right, title, and interest of the Town in and to that certain drainage easement recorded in Volume 0080007, Page 00149, Deed Records, Dallas County, Texas, as more particularly described in **Exhibit "A"**. The City Manager is authorized to execute the Release and shall record the same in the official public records of Dallas County, Texas.

SECTION 2. This Ordinance shall become effective from and after its passage.
